## Who is Who: Meet the New Eurodoc Board

**PRESIDENT****Nikola Macharová**

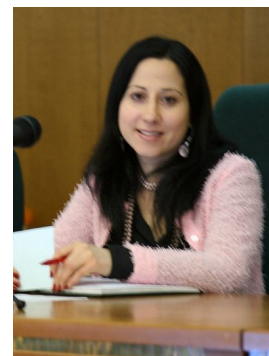

## Conference of the European Ministers Responsible For Higher Education, 28th-29th April, Leuven/Louvain-la-Neuve

The conference in Leuven/Louvain-la-Neuve was the 5<sup>th</sup> meeting on the Bologna process since the Bologna declaration was signed by 29 countries in 1999. At present, 46 countries have joined this process. The main product of the conference was the communiqué, stating the intentions and priorities for continuing the cooperation within the European Higher Education Area (EHEA) for the next decade.

As one of the opening speakers, the Czech minister emphasized the importance of Bologna in changing the educational system, and how the higher education institutions (HEIs) of Europe would play a crucial role in the economic recovery process. To adapt to the ever-changing environment of today's society, transferable skills are important, and a focus on lifelong learning is necessary. These were also focal points for the opening speech of the European Commission (EC).

Partners of the Bologna follow-up group (BFUG) gave presentations and reflections on the progress of implementation. This included European Students union (ESU), European University Association (EUA), European Association of Institutions in Higher Education (EURASHE) and European Association for Quality Assurance in Higher Education (ENQA). Afterwards, ministers/heads of delegations from participating countries were given the opportunity to comment on the content of the communiqué and come with suggestions for changes. Most of the ministers were on

overall satisfied with the communiqué, only a few paragraphs lead to discussion, mainly funding, mobility and classification of HEIs.

The plenary session was followed by parallel sessions where the ministers were discussing the suggested changes in smaller groups to try to reach an agreement. After this, everyone gathered once more in plenary for feedback from the sessions and finalisation of the communiqué. ESU tried to implement more changes into the document, especially on making sure that private founding sources should not hinder students from entering and completing higher education. Germany tried to focus more on getting private contributors to take a bigger responsibility in funding HE, instead of focusing on students, but to no avail. In the end, this part of the paragraph was not changed.

Some new changes were implemented into the communiqué, notably the rephrasing of the 20% mobility goal by 2020 for each country to instead apply to the EHEA as a whole (par. 18), an increased focus on the teaching quality of study programmes at institutions (par. 14), recognising teachers as key players and a target group for mobility (par. 19), emphasizing quality assurance (QA) and recognition of education as priorities (this as a response to the discussions on classification) (par. 22), and an emphasis on public funding as the main funding body of HEI's (par. 23).

The reason for changing the mobility goal slightly was to accommodate the

worries of some countries regarding the realism of this goal for their part. Still, mobility was emphasized by many of the ministers as very important, together with life-long learning and equal access to higher education. Paragraph 22 could had a focus on transparency tools and classification. Some argued that classification could lead to ranking lists and this became the subject of much discussion. Many countries, and especially ESU and EURASHE argued that ranking lists was not the way to go, whereas other countries, as well as the EC and EUA was viewing ranking lists as unavoidable and a good way of comparing institutions.

Next day, the conference moved to Lovain-la-Neuve, where the communiqué was formally adopted. This was followed by the new Bologna Policy Forum, in which the ministers of the Bologna countries could exchange ideas and thoughts with representatives from other parts of the world. This has been initiated responding to the growing interest for the Bologna process in other regions. At the policy forum there mainly was a plenary session where all the invited speakers spoke of their interest in the Bologna process and further cooperation. As a result of this forum, a statement was presented. A suggestion to implement a sentence about recognising the importance of stakeholder involvement in the work for developing higher education was not included due to "time shortage", though this was seen as an important statement. The participating countries agreed on the statement and that they where to meet again in Vienna, 12<sup>th</sup> March 2010. The next forum will, as in Leuven/Louvain-la-Neuve, be preceded by a special ministerial conference in Budapest/Vienna on 11<sup>th</sup>-12<sup>th</sup> March 2010.

The BFUG will work to prepare a work plan for the period to 2012, when the next regular ministerial meeting will take place in Bucharest, Romania 27<sup>th</sup>-28<sup>th</sup> April. This plan will build upon the priorities stated in the communiqué adopted in Lovain-la-Neuve.

Czech Presidency Conference “Researchers in Europe without Barriers”, 28<sup>th</sup>–29<sup>th</sup> April 2009, Prague

The conference aimed to build on the momentum created by the European Commission and the French Presidency in line with the EC Communication “Better Careers and more mobility: a European Partnership for researchers”, which identified main drawbacks for the development of researchers’ careers and mobility in Europe and suggests possible pathways within the framework of Partnership between the Commission and the Member States.

Given the slow progress in realising the ERA (e.g. take-up of Charter and Code, recruitment and employment conditions), and as one outcome of the 2007 Green Paper “The European Research Area: New Perspectives”, the EC has launched a new approach in 2008: A partnership between the EC and the Member States in order to ensure the implementation of actions. This “Partnership for researchers” comprises four key areas where measureable progress should be achieved by the end of 2010:

- Open recruitment and portability of grants (promotion of job database EURAXESS)
- Social security and supplementary pension needs
- Employment and working conditions (flexicurity principles)
- Training, skills and experience (national skill agendas, links academia-industry)

The ministers of Portugal and Luxembourg, Gago and Biltgen, were asked by their colleagues (Competitiveness Council) for a report to propose priority areas for the implementation of the partnership for researchers, a report which they delivered in December 2008. These areas are:

- Increase the number of students in science and technology related subjects
- Increase the number of PhD candidates
- Attract and retain more science and technology students and researchers (from Europe and rest of the world) including “employment contracts with an adequate remuneration to all researchers”
- Legal, administrative and funding framework

These initiatives were the focus of Commissioner Janez Potočnik’s speech at the conference. He also sees a shift in

policies since governments invest more in R&D despite the crisis. In the discussion, he supported the idea of taking the number of research contracts as indicator to measure progress within the “Partnership for Researchers”. Eurodoc president Nikola Macharová stressed Eurodoc’s support for the aims of the Partnership, but also pointed out that the ERA activities should not only be restricted to the EU member states. Other presentations of the conference focused on research climate and attractiveness of the European Research Area, on creating better

environment for researchers in Europe, on fostering young talents for research and their engagement in ERA and on developing of research skills and entrepreneurial mindset among young researchers. The imbalance between EU member states in terms of research performance was pointed out several times during the conference. The new member states often lack adequate research infrastructures, leading to brain drain and subsequent loss of financial support (“Two speed Europe”). In order to overcome this situation, the EU should support struggling member states in building modern research infrastructures.

Report on Eurodoc Conference 2009, Banská Bystrica, Slovakia, 26<sup>th</sup>–28<sup>th</sup> March

The Annual Conference and General Assembly of Eurodoc, the European Association for doctoral candidates and young researchers, was held from 26<sup>th</sup>–28<sup>th</sup> March at the Matej Bel University in Banská Bystrica. It was hosted by the Asociácia Doktorandov Slovenska (ADS, Slovak PhD Students' Association), whereas the Czech organization Studenská komora Rady vysokých škol (SKRVŠ, Students' Council of the Chamber of Higher Education Institutions) was involved in the organization.

### Conference

The conference entitled “Innovation in Europe: From Academia to Practice and Back” focused on issues of intersectoral mobility. The focus of the presentations and discussions was put on the creation of a unified labor market for researchers and on the need for increased investment in research and development. In particular, Europe's lagging behind in achieving its ambitious Lisbon Strategy has been identified as a stumbling block. The EU Commission will make further efforts to create better conditions for young researchers to improve, e.g. with regards to the issue of social security and the implementation of the “European Charter for Researchers and the Code of Conduct for the Recruitment of Researchers”.

### Workshops

#### *Fostering Cooperation*

#### *Between University and Industry*

Presented were case studies of collaborations between the academic and private sectors, from which, ideally, both will benefit. At Lancaster University (UK) postgraduate students have the option to spend one year in a company, or even to establish their own businesses. At the University of Žilina (SK), there is a

“Science and Technology Park”, which helps start-up companies and encourages good business ideas of students and doctoral candidates. A study of intersectoral cooperation in Flanders showed that the chances of intersectoral mobility are often overlooked due to lack

of information. Furthermore, intellectual property rights is an important issue, especially for industry partners.

#### *Success Stories of Intersectoral Mobility*

ScanRobot is an automatic book scanner, which the young Treventus company, a spin-off company of the TU Vienna, has developed. A representative of this company presented the company he co-founded and outlined the development

history of the idea from the laboratory to the finished product. The development of a sound business plan and securing intellectual property rights (patents), are crucial steps on this

way. In addition, it needs a lot of motivation, enthusiasm and teamwork for the successful implementation of such a project.

#### *Lisbon Strategy and Innovation Policy*

Theme of this workshop were current developments in the EU to achieve the Lisbon objectives. The COST program

(European Cooperation in Science and Technology) was presented. Trends in the

European labour market and the contribution of the regions and the universities were discussed. In summary, it was found that the national commitment is often unsatisfactory,

even though investment in research and development results in long-term growth and creates jobs.

#### *The Role of Universities in the Innovation Economy*

The mission of the universities in the 21<sup>st</sup> century was discussed: Should these only foster and administer innovations or act as “players” themselves? How does the protection of innovation combine with the open nature of universities? The diverse needs of society, politics and industry are an additional challenge.

Thomas Jørgensen presented the perspective of the European University Association on modernisation of the universities and the reform of doctoral programmes therein.

### General Assembly

Eurodoc 2009 General Assembly started with the “Annual Board Secretariat & Presidential Report”. Moving to further internal issues it ended with the election of the new board for the years 2009–2010.

The next Eurodoc conference will be hosted by ÖH Doktorat – doktorat.at from 11<sup>th</sup> to 15<sup>th</sup> March 2010 in Vienna. Further information will be given in the next issue of Eurodoc Newsletter.

## Young Researchers' Lobby in the Kremlin

*Eurodoc Member Russian Union of Young Scientists report on their recent successful activities.*

The Russian Union of Young Scientists is an All-Russian non-governmental organization established by the Congress of Young Researchers and Scientists of Russia, that took place on October 20–21, 2005, gathering more than 700 delegates that represented over 500 higher education institutions, research organizations and scientific centers from 77 regions of Russia.

The principal objectives of the Russian Union of Young Scientists are the following:

Development and realization of measures with the aim of strengthening the creative potential and social activity of young people engaged in the sphere of science, research and education;

Consolidation of young intellectuals in order to coordinate the development of well-grounded proposals concerning the improvement of various spheres of Russian society;

Development of cooperative relationships, both working and informal, among representatives of Russian researchers' community.

In recent years the Russian Union of Young Scientists has submitted proposals concerning the improvement of the scientific and technical expert examination system, the realization of the National Project "Education", increasing academic mobility, and solving young researchers' dwelling problems.

Among the Union's most recent initiatives that have been supported and implemented by Russian high authorities, the following are worth mentioning:

On July 30, 2008 the President of the Russian Federation, Dmitry Medvedev, signed the Decree of Russian Federation President Prize in Science and Innovation for Young Scientists, supporting the proposal announced on March 19, 2008 by a representative of the Russian Union of Young Scientists at a meeting of the Presidium of the Presidential Council for Science, Technology and Education.

According to this Decree, three Russian Federation President Prizes in Science and Innovation for Young Scientists were established in the amount of

2.5 million rubles each (about 70000 EUR), to support young specialists and researchers and to encourage their activity in the sphere of innovation.

The Presidential Prize will be granted from 2008 onwards to Russian citizens for their significant contributions to the development of national scientific research and innovations to stimulate the laureates' further researches and provide favorable conditions for new achievements in the spheres of research and innovation.

On July 28, 2008, the Government of Russia approved a Federal Target Program, on "Human Resources for Science, Research, Education and Innovation in Russia" for 2009–2013. The overall budget of the Program is 90.454 billion rubles (about 2.5 billion EUR).

The Program aims at creating conditions for effectively managing human resources in the sphere of research and education, as well as attracting young people to science, research, education and high-tech, and preserving the intergenerational continuity of the process.

The representatives of the Union actively participated in developing proposals for the Program, many of which were included in the final version of the document. The Chairman of Council of the Russian Union of Young Scientists,

Dr. Alexander Scheglov, was included by the government in the interdepartmental working group responsible for developing the draft version of the Program.

It is also worth noting that the Union played an important role in developing the Human Resources Program. Though being represented in the working group by only one member, those in the Union who were interested had an opportunity to submit their proposals concerning which the measures needed to be taken and issues that had to be taken into consideration when developing the draft document.

Participating in the program's development, the Union placed a special emphasis on young scientists' and researchers' interests. In particular, our organization succeeded in including the requirement of reserving no less than 50% of the remuneration for labor on research projects for young participants, insisting that some contests are to be specially organized for young scientists and researchers, etc.

All these facts illustrate the high importance of the activities of the Russian Union of Young Scientists in the interests of young scientists and researchers in Russia. It is our hope to be able to continue to play an important role not only at a national level.

## Prolonging the Survey till 31<sup>st</sup> May 2009

Eurodoc is conducting a Europe-wide survey of doctoral researchers – the first survey of doctoral researchers on this scale – in cooperation with the International Centre for Higher Education Research at the University of Kassel. The survey that launched on 9<sup>th</sup> December 2008 is now prolonged until 31<sup>st</sup> May 2009.

This is the first survey of its kind and roughly 100,000 European doctoral researchers have already been asked to take part.

Referring to the main aims and objectives of the survey in question, Karoline Holländer, last year's Eurodoc President and this year's survey workgroup co-

ordinator and survey expert, explains that the survey will help to answer major questions concerning doctoral education in Europe *"with the clear aim to improve the situation of doctoral candidates"*. Karoline Holländer, calling for everybody's participation notes: *"We invite all doctoral candidates to take part in the survey, in order to use their right to participate in the Bologna process."*

Max Reinhardt, last year's survey co-ordinator, and a Eurodoc survey expert, talking about the main aspects of the online survey mentions that *"The survey covers a broad range of aspects concerning young researchers."* The topics include qualification requirements, career

paths, funding schemes, models of training and supervision, working conditions, expected and achieved results of scientific work and mobility.

The survey was welcomed by a great number of doctoral researchers who joined this research attempt with much enthusiasm.
