
#### The Marie Skłodowska-Curie Actions Introduces New 'Guidelines on Supervision'

are key factors to enable researchers to embark on a promising career path" says Lucy. Read the full article here.


#### "You are the Generation Which I Hope Will Fix Our Society. We Will Not Leave You Alone in Doing That."

#### "Building Careers and Being Assessed: A Challenge for Young Researchers?"



president Giulia Malaguarnera Eurodoc participated in a panel discussion on ECR career development during the European Research and Innovation Days. Besides Eurodoc, the session

hosted leaders of other stakeholders, the Coimbra Group, Science **Europe** and **EARTO**. During the discussion, Giulia emphasized the need to re-evaluate research assessment criteria to include outputs and activities beyond just journal publications, such as Open Science practices, peer review, intersectoral collaborations, and science communication. #### Eurodoc Calls on the EU Council for More **Impactful Action to Address ECR Career Precarity**



Eurodoc welcomed the call from the presiding Council of the EU to strengthen research careers but believes more impactful actions are needed. Eurodoc Board Member Mathew Tata told Research

Europe that the announced measures are "appropriate and necessary" but claimed they did not go far enough, highlighting that they "barely mention researchers' wellbeing" and must also recognise professional status for doctoral candidates. Read the full article <u>here</u> (€).

#### Concern Over Colliding Calendars Between ERC **Funding Rounds**



Eurodoc and the **Young Academy of Europe** raised concerns over the time conflict between the results of the ERC 2021 funding rounds and the submission deadline for ERC 2022 calls. Eurodoc

President Giulia Malaguarnera told Research Professional that the current timeline will create considerable adversity for Europe's brightest researchers, and urged the ERC to delay the 2022 submission deadline for at least a month to give researchers time to reshape their proposals for the next round. However, an ERC spokesperson dismissed the appeals stating the delay was "the result of the transition from Horizon 2020 to Horizon Europe" and added "there is no flexibility on the deadlines". approaching. Interested scholars of any nationality and representing any research discipline can apply for attractive 2-year postdoctoral fellowships at the institutes of the Polish Academy of Sciences from September 15th, 2021

to December 30th, 2021. The PASIFIC fellows will be offered a net monthly allowance of approximately €2,500. Those who decide to come to Poland together with their families may be entitled to an additional family allowance. In addition, they will be granted a research budget of up to €93,000 per project.
